



SUBMISSION PREPARATION CHECKLIST

Authors are required to check off their submission's compliance with all of the following items, and submissions may be returned to authors that do not adhere to these guidelines.

1. The submission has not been previously published, nor is it before another journal for consideration (or an explanation has been provided in Comments to the Editor).
2. The article typed in the article template of this journal.
3. The article adheres to the bibliographic and stylistic requirements outlined in the Author Guidelines.

AUTHOR GUIDELINES

Aloha International Journal of Management Advancement (AIJMA) received the original article of research, book review, literature review, commentary, opinion, scientific news and letter to editor in all area of sciences, which has never been published, is equipped with:

1. Research license or endorsement page,
2. If the authors are more than one person, there must be an agreement signed by the researcher sequence all authors.

Editor has the authority to accept or reject the incoming articles, and the entire article will not be returned to author. Editor is also authorized to edit the article, but will not change the meaning contained therein. In student work article (scientific papers, thesis, dissertation, etc.), student is a first author.

Terms of the article is as follows:

1. Typed in article template of AIJMA (available at website)
2. Must be submitted by online registration and submission

Article must be written in English and meet the following systematic:

1. The title is written shortly at the center position.
2. The author's full name without a title written under the title, in bold at the center. Beneath it is written the affiliation of author.
3. The word "ABSTRACT" typed in capital letters, at the center, and the contents of the abstract are typed in one paragraph, without indentation. Under the contents of the abstract should be added to the maximum six keywords.
4. Introduction is written with indentation 1 cm.
5. Methods is written with indentation 1 cm. The contents adapted to the materials and research methods applied in the study.
6. Results is written with indentation 1 cm. If necessary, this section is equipped with tables and figures (photographs, diagrams, illustrations and other forms). The title of the tables are written above the table, the position in the center, while the title of the figure written below the image, with the position in the center.
7. Discussion is written with indentation 1 cm. The results are discussed by referring to the literature and the results of other studies.
8. Conclusions written with indentation 1 cm. They are presented in a narrative.
9. References and citations refer to the Vancouver style.
